Chairman Sill called the February 11, 2025, Trustees' Workshop Meeting to order at 6:30 P.M. and welcomed everyone to the meeting being held in the Trustees' Meeting Room at the Madison Township Administration Building.

Mr. Sill called for a roll call: Mr. Wayman, Mr. Sill, Ms. Hamercheck, Chief Hager, Mr. Brown, and Mr. Pasqualone were in attendance. Mr. Anderson was absent with a prior commitment.

Mr. Brown, Administrator, said he also had some comments for the Regular Meeting.

POLICE DEPARTMENT:

Chief Hager advised the Board he will be out-of-state tomorrow through Sunday, and the Police Department Supervisors can be contacted.

While at the Ohio Township Association Conference in Columbus last week, Mr. Sill stated the subject of police department response time was discussed, and some districts are struggling with the issue. Mr. Sill asked Chief Hager what the average response time is for Madison Township. Chief Hager said he has not completed that study, but he knows it is quick, and he can get that information for Mr. Sill. Mr. Brown stated in his past experience, it was probably twelve (12) to fifteen (15) minutes. Mr. Brown said occasionally an officer had to run down to South Madison, and it is a twenty (20) minute ride from Ford Road to North Madison. Chief Hager said he will have to sample emergency response times and non-emergency times. He will try to get some averages for the Board.

SERVICE DEPARTMENT:

Assistant Service Department Supervisor, Mr. Price, stated he had nothing to report for the Workshop Meeting.

Ms. Hamercheck, Fiscal Officer, stated she had nothing for the Workshop Meeting.


ZONING:
